




### Market Share of Home and ALF Visits by County and Program





### Home Visits by HBMC Providers





## Market Trends & Forecast


### The Market Today vs. Five Years Ago

The total number of patients receiving home visits in Androscoggin, Franklin, Oxford, and Kennebec Counties has remained steady, increasing by just 4 patients from 2019 to 2024, from 957 patients in 2019 to 961 patients in 2024.

The total number of home visits in Androscoggin, Franklin, Oxford, and Kennebec Counties has decreased by 2.2% from 2019 to 2024, from 3,857 visits in 2019 to 3,771 in 2024.

Overall, there is little change in the home visit market in these counties over this period, as there are relatively few house calls in this market.
